# Silver Creek / Sleepy Hollow Creek Watershed Action Planning

Meeting Notes

Tuesday, June 14, 2011 ◆ 1:30 – 3:30 PM

#### 1. Welcome & Introductions

# 2. Funding Watershed Plan Project Recommendations with Nonpoint Source Management Program Funds (Barb Lieberoff, IEPA)

Barb Lieberoff with the Illinois Environmental Protection Agency (IEPA), presented information on how to write an effective Section 319 grant application. The presentation included matching requirements, eligibility, and types of projects funded under the program. Project proposals should be tied to impairments identified in the watershed plan. Questions about the grant application process included discussion about how to identify impairments in watersheds that have not been assessed by the IEPA. Water quality modeling results from the watershed plan should be included on the grant application form.

It was noted that watershed plans should include information on the types of best management practices that will address identified water quality impairments. Information was also presented on other grant funding sources available through IEPA including the <u>Illinois Green Infrastructure Grant Program</u> (IGIG). It was noted that IGIG would be a good grant to consider for permeable pavement projects.

Lynn asked participants to share other ideas on potential funding sources for watershed planning projects. Keith Wozniak Mentioned that <u>USACE</u> is now considering watershed plan project recommendations for mitigation funds under Section 404 of the Clean Water Act. Projects need to be on land with hydric soils. He suggested we consider integrating project recommendations into a GIS database so they can be more easily indentified. Erika Turner talked briefly about federal funding programs available for farmers through <u>NRCS</u> such as the <u>Conservation Reserve Program</u> and <u>Wildlife Habitat Incentive Program</u>. Nancy Williamson also mentioned the IDNR OSLAD and Conservation Stewardship Programs as potential sources of grant funding.

## 3. Green Infrastructure Planning Update

Dawn presented a revised green infrastructure network map and green infrastructure opportunity areas identified by planning participants. Identified opportunities include new trail connections, natural area restoration and conservation, and conservation development. #### 4. Project Plan Recommendations

Dawn discussed how project recommendations should support identified watershed goals and management objectives. She reviewed some of these types of project and planning recommendations submitted to date. Examples include watershed education exhibits, a wastewater reuse study, groundwater monitoring, wetland restoration, and installing permeable pavement in existing public parking lots. Several projects have included a strong educational component as well. A suggestion was made to identify specific opportunity areas for mitigation funding. Participants identified additional projects on maps and submitted note cards. Dawn asked for specific project information to be submitted where available including the type/size/location of the proposed project, project leads, and potential planning partners. Newly identified projects included stormwater detention retrofits, streambank stabilization, and natural area restoration. Participants briefly discussed an IDOT transportation project Preliminary Engineering and Environmental (Phase1) Study for Illinois Route 31 from Illinois Route 176 to Illinois Route 120 in McHenry County. The committee meeting could be held the same day as the next meeting to make it more convenient. There were no objections. Dawn will follow up with Holly on this.
