- IV. Treasurer's/Membership Report balance \$6656.94. \$0.28 interest. Received \$270 in new membership fees not included.

#### V. Old Business

- 1. Water Sampling No sampling in April. May is questionable.
- 2. Property off Mark Ave. adjacent to the creek No information. There is no interest in the property but we are worried that the wetlands are going to be impacted. - 3. City to fund TCWC annually Laura Valdez left the city. Karena and another person have been promoted to "assistant TO the city manager". They have not committed to hiring an assistant CM. Carl is willing to make the presentation as soon as there is an opportunity.
- 4. Judson presentation to city sent a letter to the mayor re: previous conversations with Laura Valdez. Asked the mayor who would be the next best person to talk to. The mayor suggested to contact Marc Mylott. No response. Kyla Jacobsen will follow-up regarding this issue.
- 5. 319 grant
  - 2000 report from Hey & Associates has lots of good stuff. This highest priority was the end of Abbott Drive. Actually #1, #2 and #3 were done. The Abbott Dr. Project failed. Holly was going to look into whether we could re-apply for a 319 Grant. Holly said that since the project is over 10 years old and failed. The project was completed in 2004. Should not hurt it's eligibility. Especially if it is no longer working and we can make the case for water quality improvements.
  - #18 Creek realignment Another possibility would be the creek under Garden Crescent Dr.
  - We should do a field trip outside (with social distancing)

- Oaks Club Project 4-3 habitat restoration Flood plain on sandy Creek. The budget is stretched to the max.
