- 4. Membership update for 2023-24
 - a. So far the response rate is at about 60% of last year. Jeff and Becky will start following up with those who have not yet renewed and reaching out to prospective new members.
- 5. Resolution to name new Registered Agent
 - a. Whereas the Executive Committee is authorized to manage the general affairs of the corporation acting in the manner of a Board of Directors,
 - b. Whereas the previous registered agent for the Fox River Ecosystem Partnership, Elizabeth Hagen-Moeller, is now deceased,
 - c. Whereas the Executive Committee must name a new registered agent in order to be in compliance with Illinois state law,
 - d. Now, therefore, be it resolved that the Executive Committee of the Fox River Ecosystem Partnership names as its registered agent Kat Gerdts using the address of 2315 Dean St # 100, St. Charles, IL 60175 for an indefinite term with periodic review for her willingness to continue in the role.
 - e. Motion to approve the resolution Lucas King, Seconded by Rob Linke, Approved unanimously.
- Jeff Mengler informed that he is filing necessary forms: registered agent form and nonprofit form with IL SOS, IRS, and for CAGE/SAM renewal. There is confusion about what forms need to be filed when and what documentation is necessary for each filing. We will endeavor to create a checklist for future years to simplify the process and minimize confusion.
- 7. Fox River Study Group Update
 - a. USACE released their draft report: Fox River Connectivity and Habitat Study. Open for public comment until Nov 6. USACE is holding three community

meetings in September (meeting will also include IDNR and FRSG). Cindy and Alyse have sent EC members details via email. Additional communications and social media advertising information will be released by FRSG shortly. Report summary: Corps study recommends removal of 9 dams.

- c. EC committed to encourage people to attend the public meetings and speak in favor of the plan to remove dams, speak in favor of providing artistic renderings pre- and post dam removals in report, supportive funding for ancillary costs (infrastructure, ecological restoration, aesthetics) to support and spur municipality investment. Seems like USACE is setting up the municipalities to fail.
